



FORECLOSURE HELP IS A PHONE CALL AWAY

The Circuit Court of Cook County Mortgage Foreclosure Mediation Program provides **FREE** help to homeowners in foreclosure. You may be able to reach an agreement with your lender about your mortgage.

Am I Eligible?

To participate in the mediation program, homeowners must:

- be residents of Cook County
- have received a foreclosure summons from the Circuit Court of Cook County.
- live in the building in foreclosure – which may be a single-family home, single-family condominium or apartment building with four or fewer units.

What Can I Do?

Call the toll-free help line below to schedule a free meeting with a housing counselor, followed by a consultation with an attorney.
